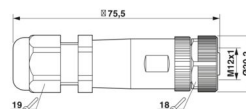

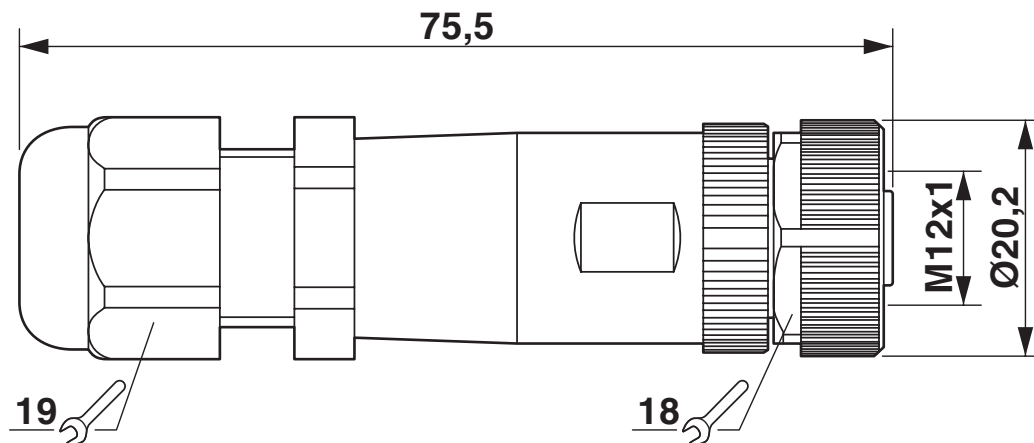

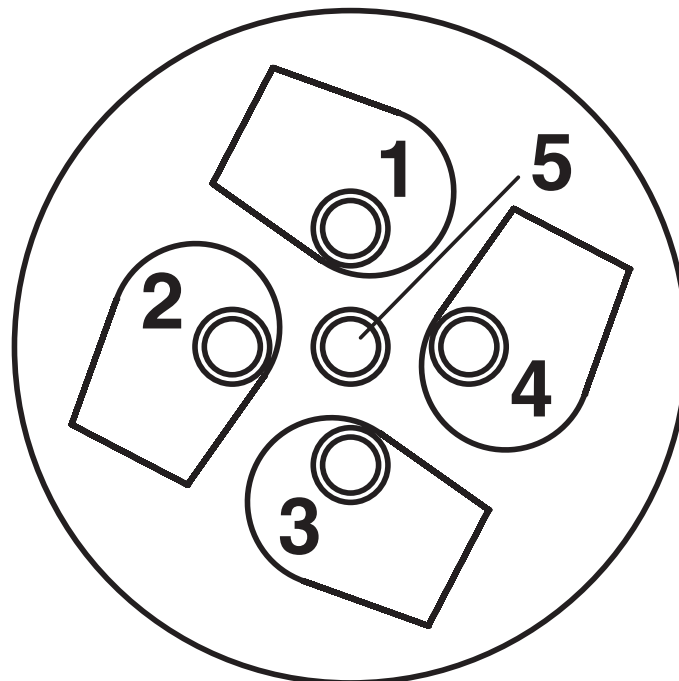

Schematic diagram

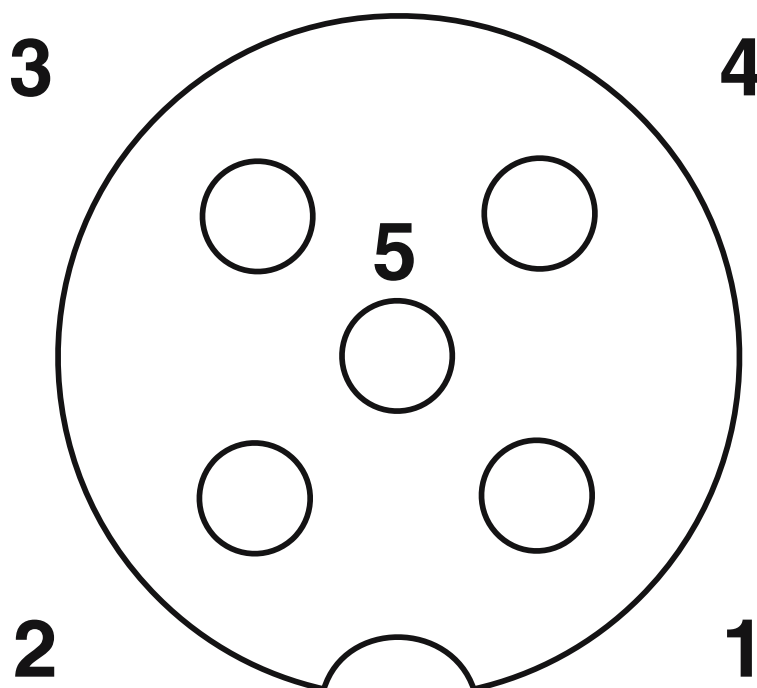


Cable connection side M12 (screw connection)
