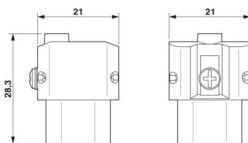

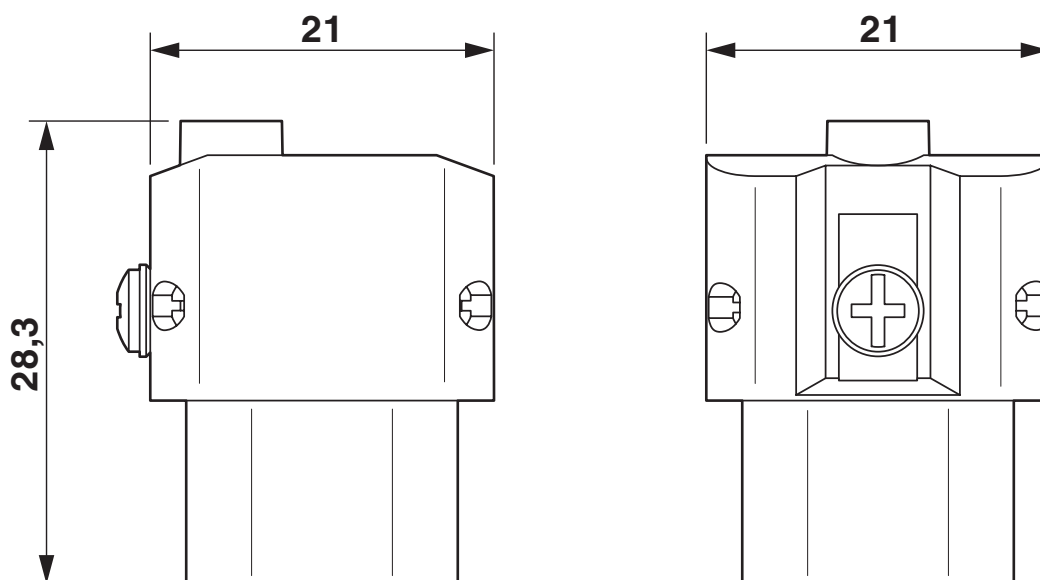

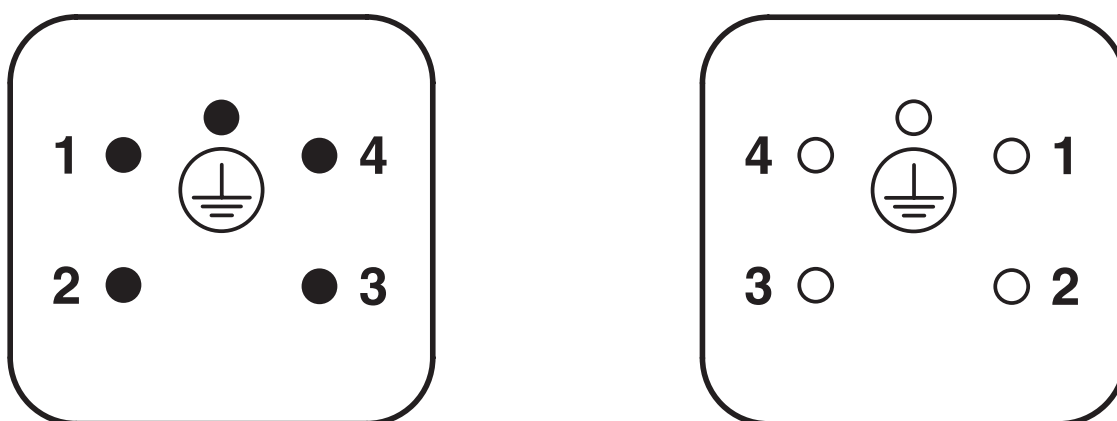

Schematic diagram

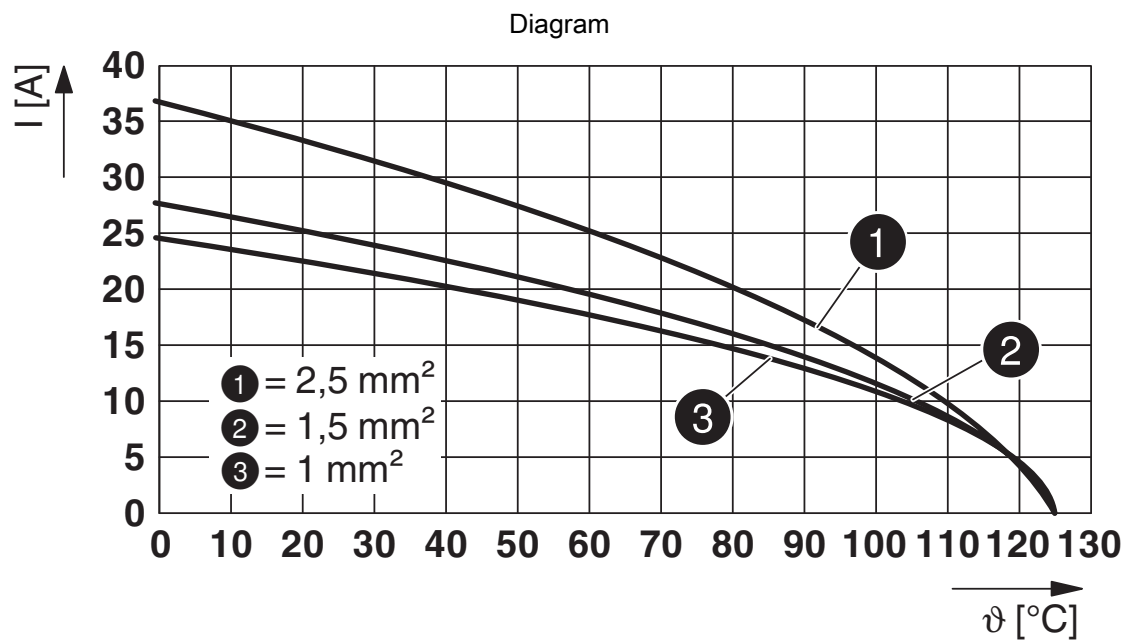


Connector pin assignment connection side: Left pin; right socket
