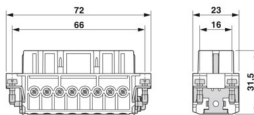

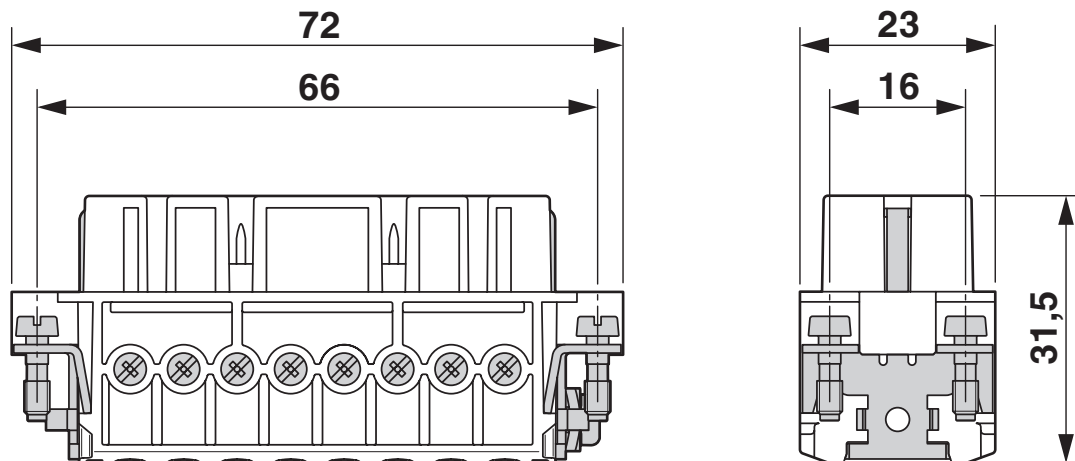

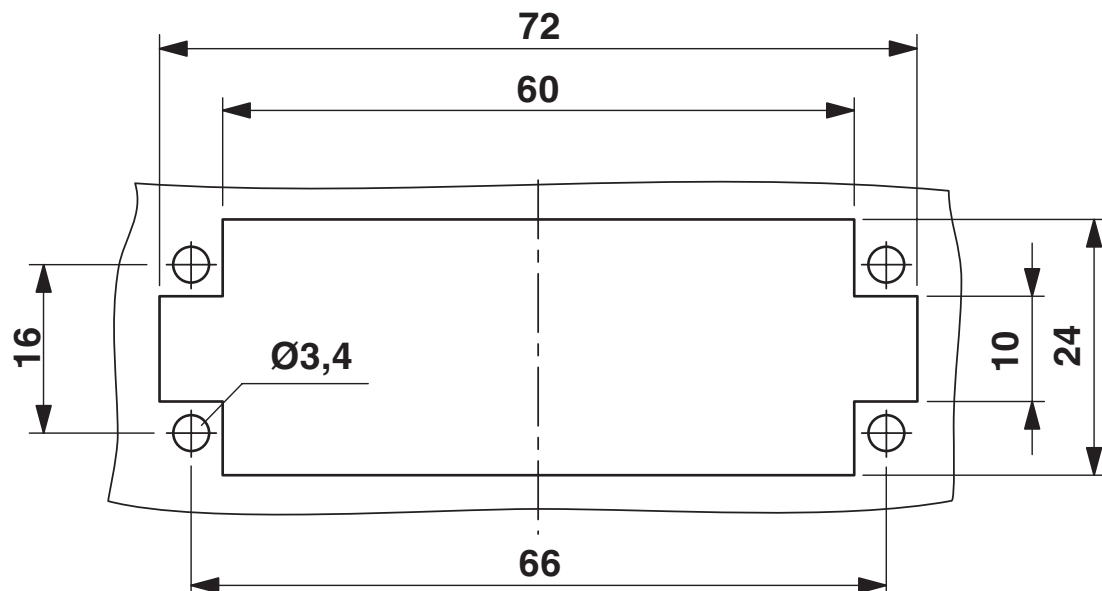

Mounting cutout when used without housing

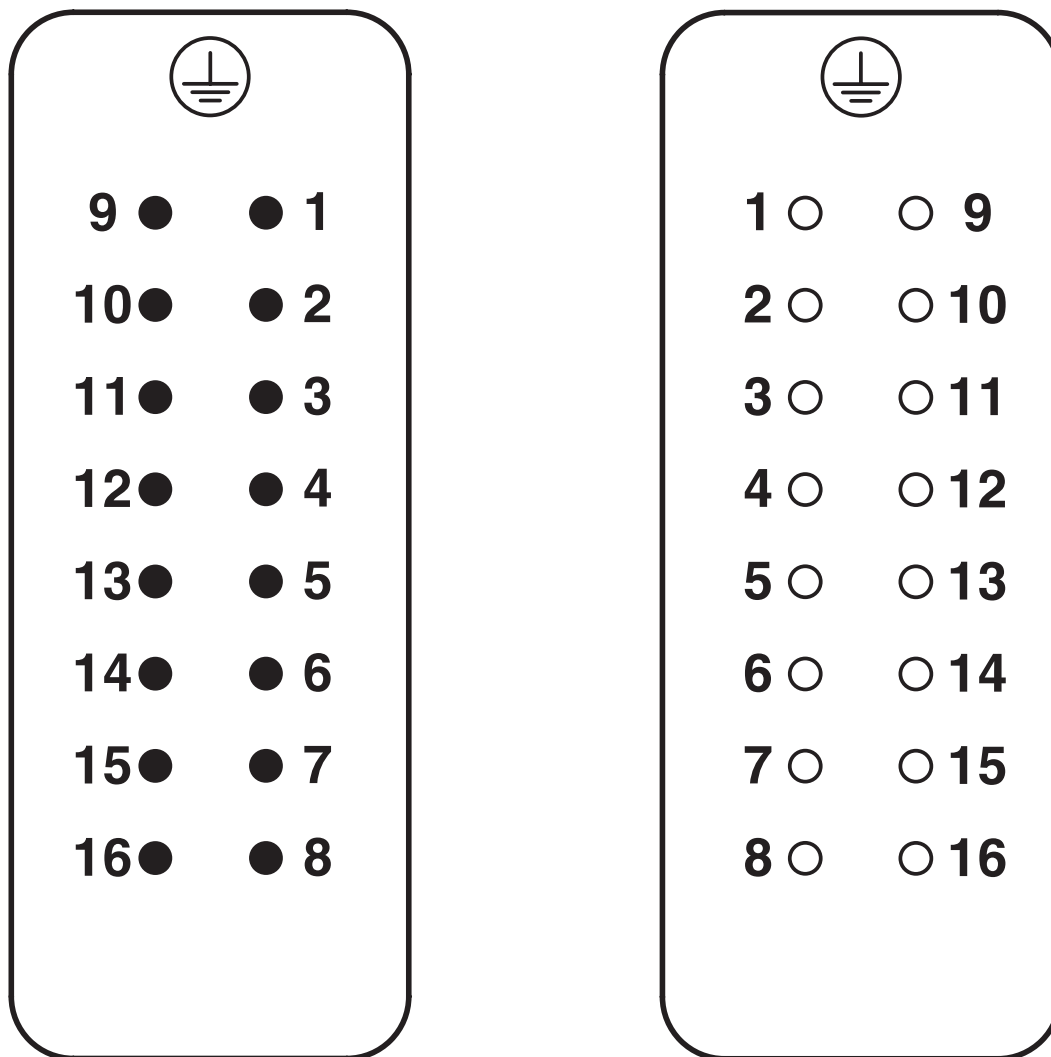

Schematic diagram

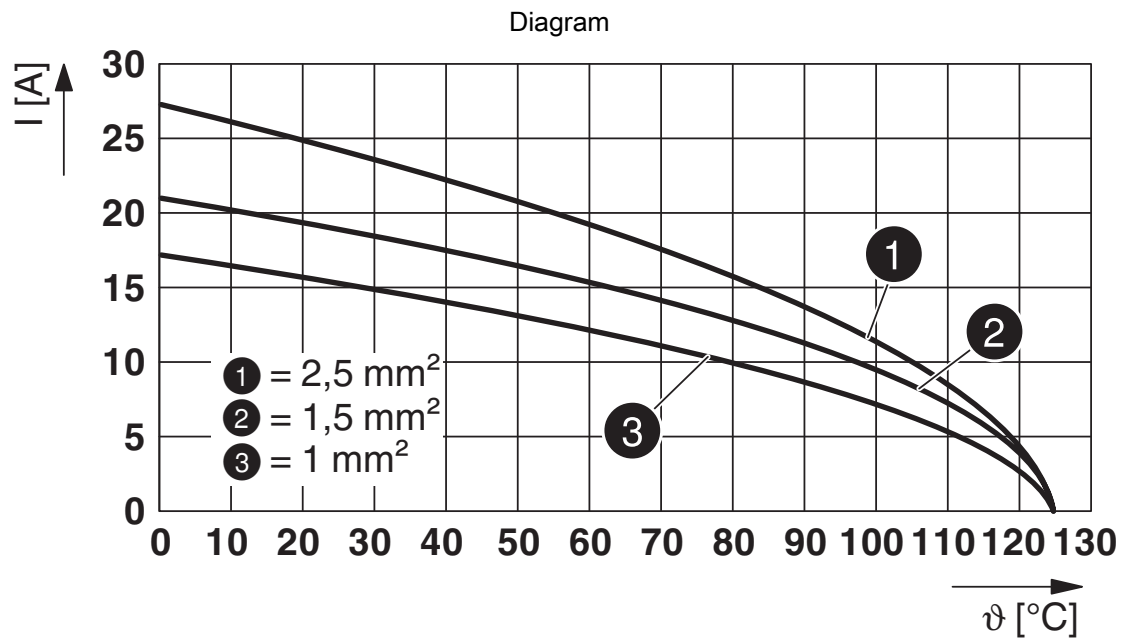


Connector pin assignment, connection side
